



The British Secret Service Unit 84 Group at Walsrode has the other dogtag and personal effects.

After the highwater had fallen a male body was found on the right side of the Aller river at Klein-Haeuslingen. The body was recovered by the farm manager Gustav Brandt and the Truckdriver Willi Friemke, both living on a farm Klein-Haeuslingen. I brought this body to the morgue of Gross-Haeuslingen. I found on a dogtag that this body was an American flyer with the name SIOMCZENSKI, CHESTER M., 36853603 T 43 44 B C. The body was nearly 6 - 8 months in the water.


